LINCOLN COUNTY COVID CASES INCREASE

Lincoln County has seen a jump in confirmed COVID-19 cases in the past two weeks for a total of 9 confirmed cases as of Monday, July 27, 2020. The most recent cases, all reported as living in the Odessa area, also include limited community spread.

Initially, Lincoln County only experienced 4 confirmed cases from March through May and was able to move into Phase 3 of Governor Inslee's Safe Start Plan by early June. At the end of June, a fifth case was confirmed and, within the past two weeks, four new cases have been reported.

"We considered ourselves lucky with previous cases because contact tracing did not indicate any community spread – the cases all contracted outside of our county," said Jolene Erickson, Community Health Director and Public Health Nurse for the Lincoln County Health Department. "Unfortunately, with the last four cases, community spread is present."

The presence of community spread confirms the need to continue taking steps for prevention -like wearing masks, staying home when sick, physically distancing, and washing hands regularly- despite perceived risk. "Some of the recent cases were completely asymptomatic (without symptoms) or had very mild symptoms," she said.

For some, symptoms can be very mild and the virus passes quickly. However, for those in the high-risk groups who have health conditions or are part of the population who are age 65 and older, COVID-19 can be deadly. "There's still so much we don't know about this virus, but we are learning more each day and we need Lincoln County residents to follow the recommended precautions based on what we do know."

Last week, Governor Inslee made changes to his Safe Start phases due to an increase in confirmed COVID-19 cases across the state. Social gatherings are limited to 10 people and live entertainment has been prohibited. The following restrictions were put in place:

GENERAL GUIDANCE:

- No indoor family entertainment/recreational centers
- (mini golf, bowling alleys, arcades, etc.) until Phase 4.
- No indoor card rooms until Phase 4.
- Indoor movie theaters limited to 25% occupancy as a Phase 3 activity.
- Expand DOH face covering order to include any shared spaces. This includes condominium hallways, hotel hallways, etc. RESTAURANT GUIDANCE:

includes the following changes (in effect July 30th as this gives restaurants time to adjust inventory and prepare):

- o Alcohol (beer, wine, spirits) service must end at 10:00 p.m. until Phase 4.
- o Close down vending game areas (pool tables, darts, video games, etc.) until Phase 4.
- o In Phase 3, table size reduced to 5 and occupancy reduced to 50% within restaurants.
- o Bars are closed for indoor service.
- o Indoor dining is limited to members of the same household at the same table until Phase 4.

FITNESS GUIDANCE to include the following changes:

- o In Phase 2, only 5 individuals (not counting staff) are allowed for indoor fitness services. These individuals can participate in group fitness classes or exercise on their own.
- o Reduce Phase 3 occupancy to 25% capacity. All group fitness classes are limited to no more than 10 (not counting the instructor).

(secular or non-secular) effective August 8 to give people with upcoming events time to prepare accordingly:

o During all phases, the maximum indoor occupancy is 20% capacity or up to 30 people, whichever is less, so long as six feet of physical distancing can be achieved between households. Outdoor weddings are limited to 30 people as well.

o Only ceremonies are permitted. Receptions are prohibited. They must follow all other parts of the faith based guidance "We're doing the best we can to minimize the spread of CO-VID in Lincoln County and we encourage all residents to abide by these guidelines," said Ed Dzedzy, Public Health Administrator for Lincoln County. "We want to see schools being able to open up in the fall and communities being able to operate at a higher level, but that won't happen unless we all take precautions to prevent the spread."
